SUBJECT: Approval of Amendment Number 2 to the Project Cooperation Agreement (PCA) for the Rio de La Plata Flood Control Project, Puerto Rico

- 1. Reference Caribbean District, CESAA-TFP-MEC memorandum (Transmission of the Draft Amendment Number 2 to the Project Cooperation Agreement between the Department of the Army and the Department of Natural and Environmental Resources of the Commonwealth of Puerto Rico for Construction of the Rio de La Plata Flood Control Project), 01 November 2024.
- 2. I approve the Amendment Number 2 to the Project Cooperation Agreement (PCA) for the Rio de La Plata Flood Control Project, Puerto Rico. The enclosed amendment shall be used for execution. Signature authority is delegated to the Caribbean District Commander.
- 3. You must ensure that the approved amendment is signed by the non-Federal Sponsor (NFS), as approved and without deviation, not later than 21 calendar days after the date of this memorandum.
- 4. The District should prepare a minimum of four final amendment originals. After signature by the NFS, the District Counsel and Project Manager shall review the signatures on the amendment, Certificate of Authority, and Certification Regarding Lobbying to ensure that each document has been signed and dated by the appropriate signatory in the correct locations. The principal legal officer must sign the Certificate of Authority simultaneously with or after the NFS representative signs the amendment. The District will retain two copies of the executed amendment, and the remaining executed copies of the amendment should be provided to the NFS. An electronic copy of the executed amendment should be forwarded to CESAD-PDP not later than 5 days after its signature by the District.
- 5. If any changes to the approved amendment are required prior to signature by the NFS, the District shall transmit a memorandum notifying CESAD-PDP of the reasons for the changes and requesting approval of the changes. Only after receipt of written approval from CESAD will the changes be incorporated into the approved amendment.
