AMENDMENT NUMBER 2 TO THE PROJECT COOPERATION AGREEMENT BETWEEN THE DEPARTMENT OF THE ARMY

AND

THE DEPARTMENT OF NATURAL AND ENVIRONMENTAL RESOURCES OF THE COMMONWEALTH OF PUERTO RICO FOR CONSTRUCTION OF THE RIO DE LA PLATA FLOOD CONTROL PROJECT

WITNESSETH, THAT:

WHEREAS, the Government and the Non-Federal Sponsor entered into a Project Cooperation Agreement on June 7, 1995 (hereinafter the "Agreement") for construction of the Rio de la Plata Flood Control Project (hereinafter the "Project", as defined in Article I.A. of the Agreement);

WHEREAS, on November 26, 2019, the Government and the Non-Federal Sponsor amended the Agreement to specify that the Government will complete construction of the Project at full Federal expense to the extent that appropriations provided under the Construction heading of Title IV, Division B of the Bipartisan Budget Act of 2018, Public Law 115-123, enacted February 9, 2018 (hereinafter "BBA 2018"), are available and used for such purpose;

WHEREAS, on October 17, 2019, the Division Commander for South Atlantic Division approved the Rio de la Plata Flood Control Project, Puerto Rico, Continuing Construction Validation Report, dated August 2019, which re-scoped the Project within the Chief of Engineers' discretionary authority by refining the design for Segments 1, 2, and 3;

WHEREAS, on March 27, 2024, the Division Commander for South Atlantic Division approved the Rio de la Plata Flood Control Project, Puerto Rico, 2023 Validation Report, dated December 2023, which further reduced the length of channel improvements by approximately .45 miles and resulted in elimination of the need to replace PR-2 bridge, and reduced the length of the Northeast Levee Segment by approximately .33 mile;

WHEREAS, the Jacksonville District transferred all responsibilities for this Project to the Caribbean District;

WHEREAS, the District Commander for Jacksonville District notified the Non-Federal sponsor in writing of the Government's determination that certain portions of the Project were complete and could function independently and for a useful purpose, and those portions were turned over to the Non-Federal Sponsor for operation and maintenance, and future such determinations will be made by the Commander for Caribbean District; and

WHEREAS, the parties desire to amend the Agreement to reflect the approved modifications to the project scope.

NOW, THEREFORE, the Government and the Non-Federal Sponsor agree to amend further the Agreement as follows:

1. Delete "and" after the seventh WHEREAS clause and insert the following:


"WHEREAS, the Jacksonville District transferred all responsibilities for this Project to the Caribbean District;

WHEREAS, the District Commander for Jacksonville District notified the Non-Federal sponsor in writing of the Government's determination that certain portions of the Project were complete and could function independently and for a useful purpose, and those portions were turned over to the Non-Federal Sponsor for operation and maintenance, and future such determinations will be made by the Commander for Caribbean District; and



"A. The term "Project" shall mean the flood control features and recreation features, as generally described in the Survey Report and Environmental Impact Statement, Rio de la Plata, Puerto Rico, dated April 1987, revised February 1988, and approved by the Chief of Engineers on January 3, 1989, as reevaluated by the Rio de la Plata, Puerto Rico, 54450, Limited Reevaluation Report, dated April 1992 and approved by the Assistant Secretary of the Army (Civil Works) on August 4, 1993, and as modified by the Rio de La Plata Flood Control Project, Puerto Rico Continuing Construction Validation Report, dated August 2019 and approved by the Division Commander for South Atlantic Division on October 17, 2019, and further modified by the Rio de La Plata Flood Control Project, Puerto Rico 2023 Validation Report, dated December 2023 and approved by the Division Commander for South Atlantic Division on March 27, 2024 (hereinafter the "Project Reports").

- B. The term "flood control features" shall mean approximately 4.5 miles of channel improvements, approximately 6 miles of earthen levees, eight culverts, a spur dike, and approximately 123 acres of wetland mitigation, as generally described in the Project Reports.
- C. The term "recreation features" shall mean the boat ramp at Dorado Bridge, as generally described in the Project Reports.



- 3. In Article I.I., replace "U.S. Army Engineer for the Jacksonville District (hereinafter the "District Engineer") with "Commander for Caribbean District" and replace all subsequent uses of "District Engineer" with "Commander for Caribbean District".
 - 4. In Article II.A.3., replace "\$94,026,000" with "\$1,088,000,000".
- 5. In Article XVI.A., delete the notice information for the Government and replace it with the following:

"If to the Government:

6. All other terms and conditions of the Agreement remain unchanged.
